Youth and Family Counsellors (YFCs)

- Kayleigh Gladstone is the new Indigenous Youth and Family Counsellor at Victoria High School.

Youth and Family Outreach

- Kara Windram is the new Indigenous Youth and Family Outreach Worker at Vic High. The position has expanded and is more challenging than in the past.
- VIRCS (Victoria Immigrant and Refugee Centre Society) has included QVCC Youth and Family Outreach in its funding application for refugees and newcomers.

# Camptastiq Summer Camp

- Full range of elementary-school-aged summer camps ran through the summer
- Provincial subsidies and bursaries were available
- A few Summer Jobs students are now working in Out of School Care I.

# Out of School Care

- Higher than usual number of children are eligible for 1-to-1 worker this year.
- Funds are available but challenges filling positions
- Great to have extra staff on hand

- Mondays, Tuesdays and Wednesdays were out-trip days
- Food Skills for Youth is hot
- Youth will be cooking at Family Night

### Early Years Programs
