Equity, Diversity and Inclusion

Equity Committee has proposed that the agency develop an Anti-racism Action Plan. They hope a Board Member and one or more QVCC Coordinators will be part of developing it. As there is a foundation of anti-racism work already in place, this will be provided to Equity Committee and to anyone working on the plan (or who is just interested). The QVCC Employee Benefits Policy has been recommended as a model to be emulated by other local Neighbourhood Houses. (Learn more about Equity Committee here)

Quivering Village Carnival and Creep-house

Our event on October 27 featured Carnival Games, a graveyard, a zombie shooting gallery and a haunted maze. It was attended by 250 people and an enjoyable experience for all ages.

Fund Development

QVCC has caught the interest of a prominent family foundation, and several meetings have taken place aimed at enhancing QVCC Child, Youth and Family Programs. QVCC was recommended to the foundation by a retired school principal who has highly valued the work of QVCC over the years. We hope that funds will be announced in January.

Expansion of the Network of Neighbourhood Houses

QVCC was represented by our E.D. at the first ever provincial gathering of Neighbourhood Houses. As well, Neighbourhood Houses were recognized at Question Period after our E.D. and several leaders met with MLAs over breakfast to build relationships and advocate for core neighbourhood house funding from the Province. The Neighbourhood Houses are considering creating a more formal provincial network and developing a joint application for interim core funding.

6. Business Arising from the Minutes

- CALUC Meeting November 7, 2023, re Evergreen Terrace Redevelopment
 - Good turnout. Cheryl, David, Leslie, NAC members and Kelly attended from QVCC/DBAC
 - David disappointed by the project. Mixed feelings were expressed about the development – amenities proposed so far seem insufficient.
 - Disproportionate focus on traffic in the discussion and Q & A. Resident concerns weren't given enough airtime.
 - Need for more housing acknowledged
 - Community Centre is beyond capacity. The redevelopment will impact this further given the probable six-fold increase in the number of residents.
 - How can peoples' needs be addressed beyond housing?
 - Concern expressed about silos: BC Housing, Capital Regional Hospital District and School District 61. Community isn't at the table for key decisions.
 - Collective curiosity shown about 950 Kings Rd and its future, as it is co-related to Evergreen Terrace. Will there be any green space left. Will there be an expansion of community services and spaces.
