6. VCAN Update

- i. QVCC Interim Sick Leave Benefits
 - Proposal from QVCC Occupational Health and Safety Committee
 - Increase sick leave from 12 to 20 days per year for all staff
 - Temporary measure to reduce sharing of symptoms at work

Motion:

Be it resolved that the Board is in favour of the recommendation to temporarily increase the number of paid sick days for QVCC staff, based on FTE (full-time equivalency), from 12 to 20 days per year, in order to reduce the spread of illness at the workplace. The modified policy will not affect annual sick bank accumulations. It will be in effect for 2023 and may be extended subject to review by the Board.
