#### 1. Agency Report - Kelly

- Gift of Good Food fundraiser
  - QVCC team raised \$3,842; Norgaard Foundation contributed \$15,000.
  - Families receive a bag of groceries each week for the term of the funding.
  - Enrolment in progress; hope to get thirty families.
- Holiday dinner
  - Over 350 takeout meals served and over 80 stuffies gifted.

- Great to welcome new volunteers to the crew this year.
- Capital Daily/United Way campaign for the Coalition of Neighbourhood Houses
  - Over \$170,000 raised.
  - QVCC share will go to Youth and Family Outreach.
- Eight-week policy project underway
  - Staffed by Mariel Cooksey, Canada Summer Jobs student.
  - Focus on staff, community social service, human resource, equity/diversity/inclusion, and other policies.
- Quadra Village Day planning
  - The event is set for the week of June 6, 2022.
  - Next meeting is **Monday, February 7, 11:30 am**, via zoom.
  - New volunteers welcome.
- COVID-19 plans redeveloped and reformalized.
- UVic meeting on community charter for equity, diversion, and inclusion (EDI)
  - Kelly attended on behalf of Coalition of Neighbourhood Houses.
    - Hosted by Dr. Moussa Mougassa from UVic Office of Human Rights and Equity.
    - Agencies gave a breakdown of EDI in local services. Seems like UVic has capacity that we can benefit from.
- QV allotment gardens
  - Beds built and irrigation in place.
  - New garden coordinator, Maddy.
  - Beds (approximately 26) have all been taken.
- Welcome mural
  - Brianna Bear is creating a mural in the reception area, with support from Gordy Bear and one of the youth volunteers.
- Stan Hagen Centre (Salvation Army)
  - Centre is closing after 20 years in the neighbourhood.
  - o Services moved to church sites in Vic West, Swan Lake and West Shore.
  - We'll need to assess what gaps this creates for our families, if any.
  - Property is being sold. No news yet on the new owner or development plans.
- Quadra Village Neighbourhood Gym lease is extended through the end of June.

  - Committee is preparing a letter of support to the province for a fund to purchase rental stock.
  - Muncie Place (Comfort Inn) Committee meeting postponed. Organizer may set up a shared meeting with the other short-term-housing facilities.
  - Next VCAN meeting, Wednesday, February 23, 7:05 pm.
- c. Villages and Corridors Dustin
  - No updates.
- d. Equity Committee David/Dustin
  - We are a subcommittee that supports inclusion and addresses EDI issues that arise in Quadra Village.
  - All are welcome to attend our Virtual Open House, Wednesday, February 2, 4pm, on zoom.
